

Publishing Agreement

The Société Mathématique de France (SMF), French non-profit organisation of public interest (*association de loi 1901 reconnue d'utilité publique*), established at Institut Henri Poincaré, 11 rue Pierre et Marie Curie, 75231 Paris cedex 05 (France), registered under SIRET number 78426370900056, represented by its president Mr Fabien Durand,

for the publication of:

Title of Contribution (hereinafter called the "Work"):

in the Journal (**Name of Journal**) under ISSN (**hereinafter called the "Journal"**)

1. The Author grants to the SMF, on a gratuitous basis, the exclusive right to publish and sell the Work in print and digital form in the Journal for ten years as of the publication, including the right:

(i) to reproduce and sell the Work in the Journal in print form on all current and future media be they analogue, electronic, opto-digital or magnetic, in the press including pre- or post-publication, micro- reproduction and photocopy intended for sale;

(ii) to translate and sell the Work in all languages and to reproduce the resulting translations on all media mentioned above;

(iii) to reproduce and sell the Work and its translations in the Journal by means of electronic files in any current and future format such as HTML, XML, PDF, ePub, on all current and future digital storage media such as web servers, USB keys, hard disks, storage cards, tablets, computers, ebook readers, smartphones, e-paper i.e. electronic paper, likely to store digital data momentarily or permanently;

(iv) to grant the foregoing rights in whole or in part to third parties.

2. At the end of the period mentioned above, the right to publish the Work, be it for commercial or non-commercial purposes, is granted by the Author to the Publisher on a non-exclusive basis, for the duration of copyright according to French law, foreign laws and current or future international treaties including any extension that may be made to such duration.

The Author shall then be entitled to publish the Work on any commercial or non-commercial website (e.g. open archive repository, personal or institutional website) or platform, under the Creative Commons licence the Author chooses, provided the full bibliographic reference of the Work's first publication in Journal is mentioned.

3. The Author warrants that the Work has not been published before in any form except possibly as a preprint or postprint, that the Work has not been submitted to another

publisher, that no author entitled to credit has been omitted, that the authors listed above are listed in the proper order, and that the Author has been fully appointed by the co-Authors when entering into this Agreement. The Author warrants that the Work contains nothing likely to violate legal provisions, infringe anyone's copyright, or otherwise lead to liability of the SMF; the Author also warrants to the Journal full and peaceful exercise of the granted rights against all disturbances, claims and evictions of any kind.

4. The SMF undertakes to publish the Work in the Journal, and to submit before publication a layout proof of the Work to the Author for approval, which the Author shall return with the statement "Pass for press" if satisfied.

5. As of the signing of the present agreement, i.e. even before publication of the Work in the Journal, the Author retains the exclusive right to post the preprint or postprint manuscript version of the Work, on the Author's own website, on the institutional repository or any other non-commercial platform giving free access to all without prior registration), provided no commercial use and no derivative works is permitted.

When posting the manuscript version of the Work on any such websites and platforms, the Author undertakes to mention the first publication of the Work by the SMF in the following manner: "First published in [*Journal*] in [volume and number, or year], by the Société Mathématique de France".

The Author who wishes to put that preprint or postprint manuscript version of the Work under a Creative Commons License, may choose only one license: the CC BY License. It enables all people interested to use the Work on the condition that they credit the Author.

Academic social networks (such as ResearchGate or Academia.edu) are not open archive repositories: should the Author post the Work on such a platform, the Work must be linked for sustainability reasons to the open archive repository or to the SMF publication platform where the Work has been posted.

5. The present agreement shall be governed by French law.

6. In case the Work has been co-written by multiple authors, the Author hereby confirms that he/she has been duly appointed by the co-authors to sign the present Publishing agreement on their behalf. The term "Author" then refers to each and all of them, jointly and severally.
